

PUBLIC NOTICE

TAKE NOTICE THAT, pursuant to Section 62(2)(a) and (b) of the Public Procurement Act, Cap 410 and Regulation 99 of the Public Procurement Regulations, 2013 as amended, a tenderer who has been blacklisted and barred from taking part in public procurement by a foreign country, international organisation or other foreign institutions shall automatically be blacklisted from participating in public procurement in the United Republic of Tanzania (URT). Thus, in the case of fraud and corruption, the tenderer shall be debarred for such period as stipulated by that foreign country, international organisation or foreign institution plus a further period of ten (10) years; and, in cases other than fraud or corruption, shall be debarred for such period as is debarred by that foreign country, international organisation or foreign institution plus a further period of five (05) years.

TAKE FURTHER NOTICE THAT, it came to the knowledge of the Authority that M/s **EGIS WATER AND MARITIME** Of Siege Social:15, avenue du Centre-CS 20538, Guyancourt-78286 st Quentin-en-Yvelines Cedex - France participated and became a successful tenderer in Tender No. ME-011/2022-2023/C/18 advertised by the Ministry of Water (PE) in the URT for the Provision of Consultancy Services for the Preparation of Employer's Requirements, ASIA and Tender Documents and Construction Supervision for Water Treatment Plant (WTP) and Design Review for Conveyance Systems to Dodoma. However, before signing the contract, the PE realised that the successful tenderer had shared the same address with its associated company, namely M/s EGIS EAU S.A.S and EGIS INTERNATIONAL, which was involved in fraudulent and corrupt practices and hence blacklisted and debarred by a foreign institution (Grefe du Tribunal de Commerce in Republic of France) for a period of three (03) years from 3rd January 2024 up to 2nd January 2027.

Given the debarment status of the tenderer and the above-cited automatic legal effect of the URT procurement law for tenderers blacklisted and debarred by foreign organisations or


institutions for fraud and corruption, the tenderer is automatically debarred and blacklisted from participating in public procurement in the URT for a further period of ten (10) years. Therefore, **M/s EGIS WATER AND MARITIME**, its associates and directors are debarred and blacklisted from participating in public procurement for a period of **three (03) years from 3rd January 2024 to 2nd January 2027** as debarred by that foreign institution (Greffé du Tribunal de Commerce in the Republic of France). The company is debarred for a further period of ten (10) years from **3rd January 2027 up to 2nd January 2037** from participating in public procurement in the URT for fraudulent and corrupt practices pursuant to Section 62(2)(a) of the Public Procurement Act, Cap 410.

THEREFORE, any person who, at the time of debarment, was concerned with the management of the affairs of the debarred company (**M/s EGIS WATER AND MARITIME**) as director, partner, agent or officer is also not allowed to participate in public procurement or disposal by tender in the URT for the same period pursuant to Section 62(11) of the Public Procurement Act, Cap 410 read together with Regulation 101(3) of the Public Procurement Regulations, 2013 as amended. The details of the blacklisted company are indicated hereunder,
