## **PUBLIC NOTICE**

Pursuant to Section 72 of the Public Procurement Act, Cap 410, the Authority has powers to debar firms or individuals from participating in public procurement and inform procuring entities and general public to that effect. Based on the foregoing provisions, the GENERAL PUBLIC is informed that THE AUTHORITY HAS DEBARRED M/s Ci Group Limited, M/s Codeban Co. Ltd and M/s Marania Group Co. Ltd (including their directors, partenrs, officers and agents) for a period of one (01) year) from participating in public procurement and disposal of public assets by tender with effect from 17<sup>th</sup> April 2025 to 16<sup>th</sup> April 2026 on ground of fraudulent acts (forgery).

The afore said companies participated in No. FA/2024/2025/TR212/G/17 for Supply of Staff Uniforms under Three (3) years Framework Agreement which was advertised by Tanzania Electric Supply Company Limited (TANESCO. It was one of the tendering requirements for each tenderer to submit a physical sample of respective goods evidenced by a test certificate in line with EN 150 ISO 20471 which is verified by Tanzania Bureau of Standards (TBS) on conformity. In compliance thereof, M/s Ci Group Limited submitted four (4) test reports; namely Nos. TL/17853/2025, TL/17850/2025, TL/17851/2025 and TL/17854/2025, all dated 30th December 2024, M/s Marania Group Co. Ltd submitted a test report No. TL/13292/2025 dated 3rd January 2025 and M/s Codeban Co. Ltd also submitted four (4) test reports; namely Nos. TL/12295/2025, TL/72836/2025, TL/18834/2025 and TL/23493/2025, all dated 2nd January 2025. Upon verification, TBS confirmed that all such test reports were false.

Following issuance of debarment order, procuring entities and the general public are hereby **NOTIFIED** that all persons who were involved in the management affairs of the aforesaid companies at the time of debarment as directors, partners, agents or officers are also not allowed to participate in public procurement or disposal of public assets by tender for the same periods. Also, pursuant to the provisions of Section 72 (8) of Cap 410, such directors, partners, agents or officers are not allowed to incorporate any
